Highways (040)

Cllr Jones informed the council that the Tarmacking vehicle will be in the area one week every month until October/November.

The Council was informed of the following highways observations:

- a. Traffic Lights at Newbridge on the A495 are not working correctly.
- b. Council was informed that the A458 (between Heniarth and Cyfronydd) has, due to extreme heavy rain fall, flooded 3 times on the trot, with one of the contributing factors being caused by the buildup of silt causing the bridge to block up. CCllr Jones was requested to propose a motion to Powys Council to get the River Authority to reconsider their position on dredging the rivers.
