- b) A letter had been received for a donation from Llangyniew Church, the donation, if successful, would go towards the Community facility that is currently being built, which will benefit the extended Community, in light of this Councillors were all in favour to donate £750.00 now and the backdated £750.00, which is held in reserves from 2021 will be paid on completion of all works. 8. Finance

11. Planning -

a) Application Reference: 23/1262/REM

Section 73 application to vary condition 2 of reserved matters application 20/1187/RES in relation to approved plans - Development land adjacent to Pant Y Ddafad, Pontrobert.

Councillors were in favour to support this application due to ageing population, but shows why Councillors were unable to support the below. b) Application Reference: 23/1261/REM

Section 73 application to vary condition *5*(i) of reserved matters application P/2016/1337 in relation to affordable dwellings - Development land adjacent to Pant Y Ddafad, Pontrobert.

Councillors present were in favour not to support this application. Concerns were raised that by approving this application, the young working class would not be able to remain in the Community, which then has an effect on the sustainability of the local schools, language and culture.

Many young people in the area are unable to afford houses at current prices and therefore local housing needs to be affordable

Due to the Clerk's work load, Councillors agreed to change the meetings ongoing to the Second Wednesday of the month.

13. Pylon Consultation -

The Clerk advised that there would be a public meeting in Meifod Village Hall on Monday 25th September at 7.30, all are welcome. Ccllr. Wilkinson had advised the Clerk that he would like representation from Llangyniew

Council, as well as Meifod as he wanted to hear the views of both Communities.

The first consultation had commenced and would close on 18th October. Bute are holding a drop in centre on Friday 29th September in Meifod and on Saturday 23rd September in Llanfair Institute.
